1. Item Number: This is your "Account Number" when calling our office please have this number handy.

2. Exemption Description: This section details any exemptions you have previously applied for and are receiving for the current tax year. Your yearly savings based on your exemptions is also shown here. (Please note some exemptions must be applied for yearly.)

3. Assessed Value: This is the dollar value placed on a parcel of property by the Assessor's Office. It is computed by analyzing thousands of individual sale transactions, thousands of inspections and a thorough

study of all Brookhaven Town neighborhoods. It is the Assessor's estimate of market value. It is important for maintaining equity between and among all taxpayers in Brookhaven.

4. Full Value: This is the dollar value of your property which is determined by the Brookhaven Town Tax Assessors Department.

5. Prior Year Tax Information: This section shows prior years tax payment history.

6. District Tax Amount: This is the percentage of your tax bill being allocated to the follow

ing: School Tax, County Tax, Town Tax and Other Tax. These should add up to 100%

7. Tax Amount: This is the total dollar amount of your taxes computed yearly.

8. First / Second Half Tax: These are the dollar amounts of your 2 yearly property tax payments. First Half Due: January 10th / Second Half Due: May 31st

9. Total Tax: This is the dollar amount of your entire tax bill. If you care to pay your entire bill all at once please remit both payments prior to January 10th to avoid penalty.
